#### Appendix C

#### Alumni Candidate Requirements

SECTION C.1. SCOPE The contents of this appendix apply only to those alumni that were eligible to elect during their final semester in school as either an undergraduate or graduate student and that are not enrolled students at the University of Michigan.

SECTION C.2. CHAPTER INVOLVEMENT Each candidate will complete a total of 7 hours of TBP activities. A minimum of one hour must come from a TBP service event.

SECTION C.3. INTERVIEW Each candidate must undergo a casual interview by the Membership Officer and/or at least one active member. This interview may be conducted electronically at the discretion of the Membership Officer.

SECTION C.4. CHARACTER Each candidate will be assessed for exemplary character. This will consist of filling out an information survey with questions focusing on exemplary character.

SECTION C.5. DUES Each candidate must pay the one-time only membership dues as set by the Officer Corps.

SECTION C.6. INITIATION Each electee must attend initiation. This is an absolute requirement and cannot be made up. An electee who has completed all other requirements but who misses initiation may not become a member of Tau Beta Pi. He/she may either attend the initiation of another chapter or must wait until the following term to attend the initiation.

SECTION C.7. TIMING Each alumni candidate will be considered active in a given semester when active progress is made towards the initiation requirement. Active progress is defined as completing two hours in a given academic semester.

b. Amend Bylaw IX.3 to allow the officer corps to modify the new alumni candidate requirements as it can with the undergraduate and graduate electee requirements:

SECTION IX.3. APPENDIX AMENDMENT Appendix A (Electee Requirements), Appendix B (Graduate Electee Requirements), Appendix C (Alumni Candidate Requirements), Appendix D (Distinguished Active Status Guidelines), and Appendix E (Prestigious Active Status Guidelines) may be modified at the discretion of the Officer Corps. Appendices F.5, G.3, and H may be modified at the discretion of the Officer Corps per the procedures outlined in Bylaws I.4.a.iii, I.5.c, and I.4.a.vii respectively.

- X. Graduate and Undergraduate Candidate Character Recommendation (Ethan Pacheck & Morgan Chencinski epacheck & chencmor)
  - a. Criteria
    - i. Eligibility Code (see last page of agenda)
      - 1. Please leave the room if you are not an initiated member of TBP
      - 2. Must be an 'active' member (per Bylaw VIII) in order to vote
      - 3. Must be currently enrolled student to vote
    - ii. 3/4th affirmative vote needed for candidate to be recommended
    - iii. Abstention from voting is the same as a 'no' vote

- iv. All discussion is to be considered strictly confidential; nothing leaves this room
- v. Discussion of a candidate will be limited to ten minutes total. No one may speak about any given candidate for more than one minute, and discussion should be limited to concerns regarding a candidate's character.
- vi. Result of this meeting is a recommendation to Third Actives about a candidate's character

# THE ELIGIBILITY CODE OF

# THE TAU BETA PI ASSOCIATION

(Adopted by the 1926 Convention)

In order that there may be a more uniform basis for selection of members for Tau Beta Pi, these suggestions are offered. It is expected that a copy of this statement be given each active member before every election, and it may at times serve as a general expression of our policy in the selection of members.

Distinguished scholarship, while the primary requisite for admission, must not be considered the sole criterion.

After the scholastic requirements have been fulfilled, the selection shall be based on integrity, breadth of interest both inside and outside of engineering, adaptability, and unselfish activity.

We consider that true integrity is the sine qua non for membership in Tau Beta Pi, that it transcends in importance scholarship, activity, and every other qualification. Without private and public integrity, we believe that no organization is worthy of existence. Under integrity, we include honor and high standards of truth and justice.

Breadth of interest sufficient for eligibility in this Association will enable people to maintain their positions in their community by the exercise of qualities other than engineering ability.

True engineers must be able to adapt themselves ingeniously to all circumstances and conditions, making them conform to the desired purpose.

The rating of people on the degree of unselfish activity manifested, is intended to indicate that Tau Beta Pi believes that none can become worthy engineers without the welfare of associates, organizations, and the community at heart. It is furthermore expected that they display willingness to aid and assist in worthy causes by their actual campus record. However, the fact that people may not have shown unselfish activity to an appreciable degree throughout their courses of study is no infallible indication that they would not if the opportunity offered. The most conspicuous illustrations of this are those students who are self supporting, for which due allowance must be made and due credit given. *In fine*, it is in this capacity for the unstinted giving of their best, without thought of remuneration, that we believe lies one of the most sensitive tests for determining candidates' rights to bear the name and wear the Bent of Tau Beta Pi.

Motions may be made anyone who currently has the floor (the right to speak). The chair will acknowledge the motion and ask for a second. If there is no second, the motion dies for lack of second. If there is a second, an objection may be made. If there is no objection, the motion succeeds by unanimous consent. If an objection is made, the motion is either debated (debatable motion) or goes to vote (non-debatable motion). Privileged Points may interrupt the speaker; cannot be objected to.
