XI. Undergraduate Candidate Character Recommendation (Ki-Joo Sung - sungkj)

- **1.** Eligibility Code: must have "Active" status please leave the room if you are not an Active.
- 2. Candidate election requires 3/4 affirmative vote (abstentions count as "no"s).
- **3.** All discussion is strictly confidential and limited to ten minutes total per candidate. No one may speak about any single candidate for more than one minute and comments should be limited to concerns regarding a candidate's character.

XIII. Constitution & Bylaws Changes (Natalie Eyke - neyke)

- **1.** Added to Constitution, Article II: This chapter is organized for charitable, educational, and scientific purposes under section 501(c)(3) of the Internal Revenue Code, or corresponding Section of any future federal tax code.
- 2. Inserted new Article V: (moved from Bylaws, reworded) "Dissolution": In the event that the chapter ceases to exist, any residual assets are bequeathed to the "Tau Beta Pi Centennial Endowment Fund" with the University of Michigan. For the purposes of this section "residual assets" do not include initiation supplies, any Tau Beta Pi or Michigan Gamma insignia, or any assets belonging to joint ventures. Assets belonging to joint ventures must be left to the adjoining parties to be disposed of at their discretion. Initiation supplies and Tau Beta Pi or Michigan Gamma insignia must revert to the national organization, to be disposed of at its discretion. Should any of these result in assets being distributed to an organization not dedicated to one of the exempt purposes outlined in Article II, those assets will be instead distributed to one or more such purposes on a case-by-case basis.
- 3. Removed Bylaw VII.4 (moved to Article V, reworded).
- **4. Requires 3/4 Affirmative Vote to pass (abstentions count as "no"s).** Must be approved by 5/7 of the Advisory Board within two weeks.
